Continuation of discussion of Commission priorities and projects.

motion / recommendation

background

For the work session tomorrow I have prepared the attached spreadsheet to help facilitate the discussion. This is meant for facilitation purposes only. Most of the line items came from the Commission discussions on the topic.

Column D shows the category of the American Rescue Act that the items fall under. Category 1(C) is the replacement (lost) revenue category. The estimated lost revenue for 2020 and 2021 is \$7,426,723. We believe that money is simply a replacement of that lost revenue and the Commission is free to use it as it sees fit and those expenditures will not have to meet one of the specific categories of the Act.

Column E shows amounts. These are not staff recommendations, just placeholders for what could be done for that line item. The plan is during the work session the Commission will provide consensus on the amount, if any, to move to column F as an item the commission wishes to allocate funding to. The spreadsheet will be live and will show a running total of the amount available for that category for tracking purposes.

At the bottom of the spreadsheet I listed other long-term projects that I did not include for funding from this round of stimulus money. The commission could pull from that list or add other items as it sees fit.
